In reference to BRGF allotment order no.21 vide no. 186-(Sanction)-RD/CCA/BRGF/1C-5/08 dated 17.10.2011 of Panchayat & RD Deptt. Govt. of West Bengal of Rs. 8.07 Crore, an amount of Rs.723.63012 (Rupees Seven Hundred twenty three lakh sixty three thousand twelve) only is hereby sub-allotted as 1st instalment, 2011-12 to the GP, PS & ULBs as per break up shown in the annexure to the memo no.186-(Sanction)-RD/CCA/BRGF/1C-5/08 dated 17.10.2011 of Panchayat & RD Deptt. Govt. of West Bengal as circulated vide this office memo no. 931/20/PZP dated 31.10.2011.

The Gram Panchayats where Jeebika Sevaks working are being sub-allotted with an extra amount of Rs. 48000/- for their remuneration @ Rs. 4,000/- per month for 12 months for 2011-12 and the Advice amount of that GP would be scheme amount plus 48000/-.

Zilla Parishad share amounting to Rs.83.36988 lakh only is to be transferred to the designated bank account for BRGF of Purulia Zilla Parishad.

The sub-allotment has been made on account of payment of Central Assistance against the approved annual plan for the financial year 2011-12 on the basis of norms adopted for allotment of fund recommended by the 3rd State Finance Commission.

The fund will be utilized for implementation of programmes under BRGF against already approved,/sanctioned schemes under the District Plan for the year 2011-12 and accounts will be maintained in accordance with the BRGF Programme Guidelines. Monthly progress report on the prescribed format will be submitted by the 5th day of the following month. Utilization Certificate will also be submitted in prescribed format.

Executing agency has no authority to incur any expenditure unless such expenditure is covered by the sanction of the appropriate rules/authority. Under no circumstances any expenditure should be incurred in excess of allotment or in deviation of the guidelines/procedures prescribed in respect of this fund
